MASONIC PIN APPLICATION GUIDELINES

1. THE APPLICANT MUST FILL OUT THE APPLICATION AND SIGN IT.
2. THE LODGE SECRETARY MUST ATTACH ALL MEMBERSHIP DOCUMENTATION TO THE APPLICATION, SIGN THE APPLICATION AND APPLY THE SEAL OF THE LODGE TO THE APPLICATION.
3. THE WORSHIPFUL MASTER MUST REVIEW THE APPLICATION, SIGN AND DATE THE APPLICATION AND SUBMIT THE APPLICATION TO THE GRAND SECRETARY.
